AWARDS: Ribbons for 1st, 2nd, 3rd place in 2D, Acrylic, Oil, Watercolor 3D, and Photography;
Ribbon for Plein Air done on *at either ELC or the PI National Wildlife Refuge*,
Cash (\$100) for "Best of Show" (2D includes pen & ink, charcoal, pencil etc.)

EXHIBIT RULES:

1. Work **must be nature-related and be for sale and have been done in 2022-23.**
2. Mediums: Paintings, digital art, sculpture, pottery, photography, pastel, mixed media, carvings, stain glass, other.
3. A 30% commission will be deducted from the sale of any artwork, 5% to Environmental Learning Center and 25% to PICS. Sales Tax will be collected and paid by ELC.
4. Entry Fee: \$25 per entry, maximum **2 entries**. Send one copy of entry slip along with check payable to PICS at PO Box 781903, Sebastian, FL 32978. The other copy of entry form is attached to the back left side of your artwork – **PLEASE PRINT.**
5. Size Restrictions: 60" on any one side and piece can be framed or gallery wrapped 1 1/4". PICS reserves the right to reject any improperly presented works and assumes no liability for loss or damage
6. Presentations: Sculpture and other three dimensional work will be presented on a table unless the artist provides his/her own pedestal which is preferred.
7. Two dimensional works must be properly framed and in new condition. Wire hangers only, **no saw-toothed hangers.**
8. Reproductions: Not allowed, all work must be **original** and not in this show before. Show organizers reserve the right to reject entries deemed inappropriate or improperly presented.
