Maggy Bowman was a founder of Pelican Island Audubon Society, the Environmental Learning Center, and the Marine Resource Council. Throughout her lifetime Bowman was an outspoken advocate of the environment and conservation in Indian River County, a passionate birder, a proponent of quality education, a writer, a teacher, and a government official.
